



## AARP Tax-Aide Locations in the Twin Cities Southeast Metro Area



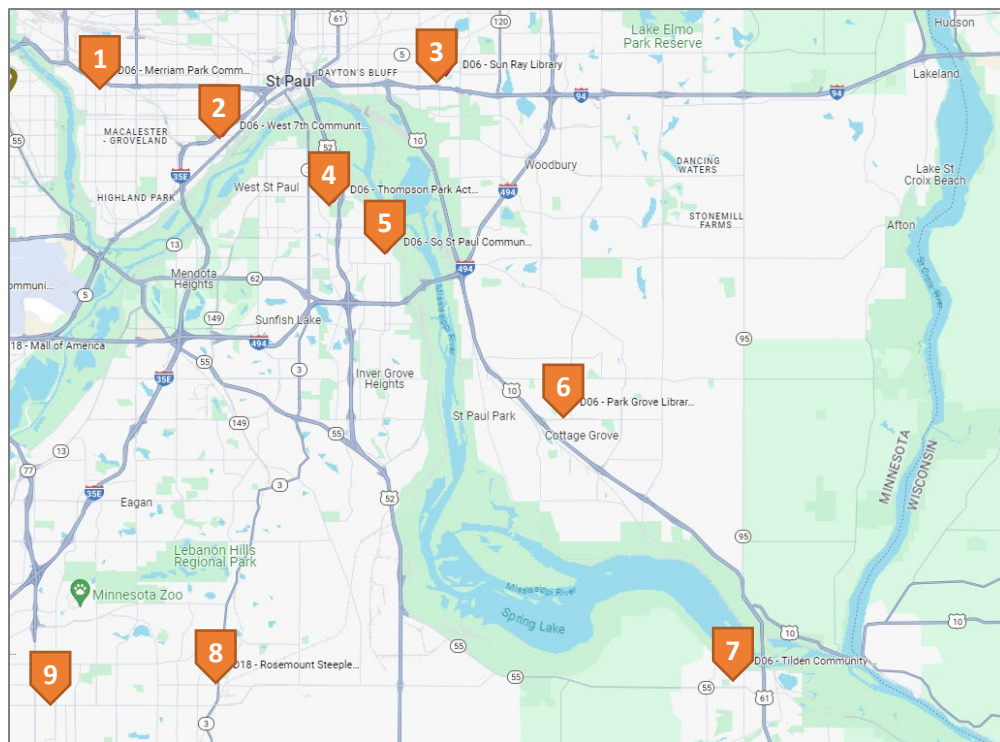
In 2024 there will be nine sites in the Twin Cities Southeast Metro Area where AARP Tax-Aide counselors will meet with taxpayers for a tax appointment. At the appointment, Tax-Aide staff will interview the Taxpayer, review their information and tax documents, prepare the tax return, and give a copy of the completed return back to the Taxpayer.

The completed tax return will then be electronically filed with the IRS and the Minnesota Department of Revenue.

Please note that out-of-state tax returns cannot be prepared at these sites.

**All appointments will be by advance registration – There will be NO walk-in service in 2024**

## How to Make an Appointment

Each of the sites will make appointments for their respective site. People can either call the listed phone number or can stop by a site and talk with a receptionist / front desk person.

People must furnish their name and phone number as a minimum. If they have an active email address, they should provide it as well so a reminder message can be sent to them a week or so in advance of their appointment.
